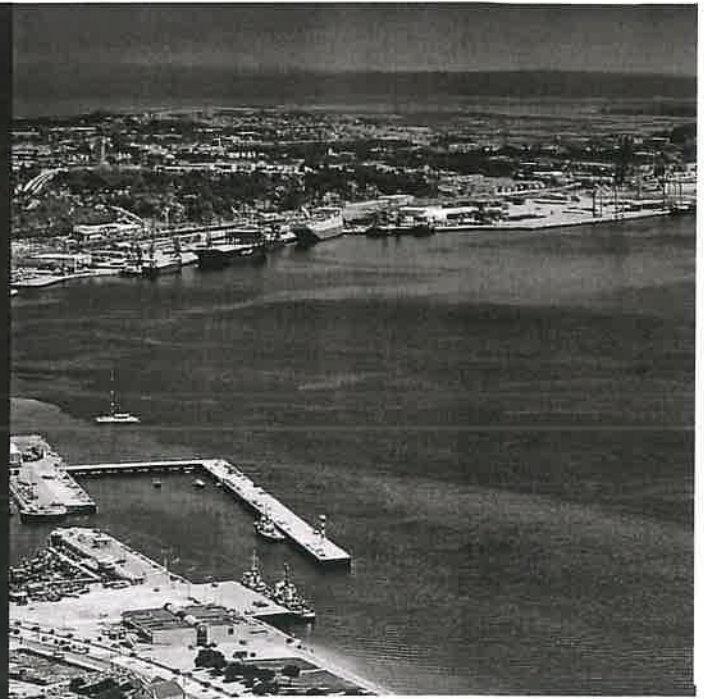

Renowned for staging key events such as the Olympic Marathon Swim Qualifiers in 2012 and 2016, and the Open Water Swimming World Cup for the past three years, Setubal's open ocean waters offer a familiar and rigorous stage for this year's World Cup Final.

With dedicated support from organising committees, local authorities, officials, and volunteers, you are in safe hands in these great cities.

I offer my heartfelt gratitude to the host cities and sponsors for their steadfast trust and commitment to making 2026 a remarkable year for open water swimming. To all athletes, I wish you success throughout this eagerly awaited racing series.

## 9. PARTICIPANTS

Entries will be accepted only from National World Aquatics Member Federations which must also register a team official for each respective competitor. A team official can be responsible for up to two (2) competitors only. The team official is responsible for representing their competitor(s) at the Team Leaders Meeting, and feeding the competitor during the event(s). **A competitor without a coach present will not be allowed to start the race** unless World Aquatics has been previously informed.

## 10. ENTRY PROCESS

All National Federation registrations and sport entries must be done through the World Aquatics General Management System (GMS) via <https://data.worldaquatics.com/> Each National Federation must complete their registrations before the designated deadlines.

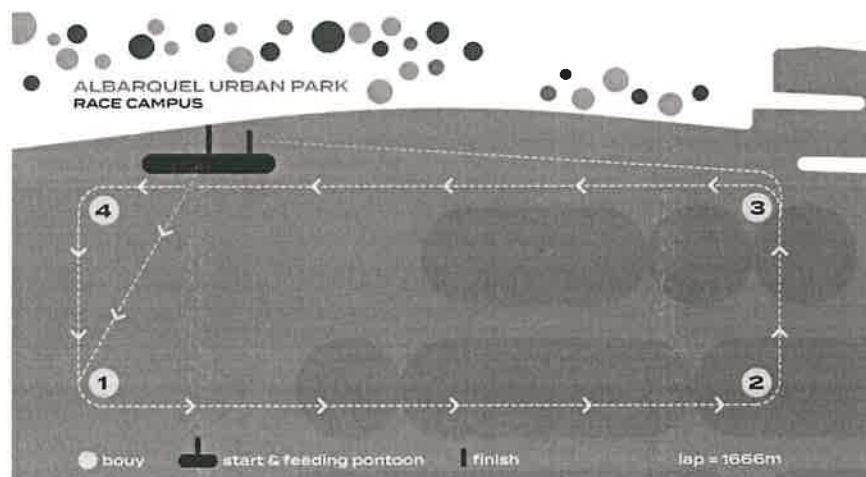
## 11. TEAM LEADERS MEETING

The Team Leaders Meeting will take place on Friday the **19th of June at 18h30 at the Hotel Novotel**. At least one representative from each National Federation must attend this meeting.

## 12. VENUE & COURSE INFORMATION

The **10k** Competition will be organized on a **1.66km** course, swimmers must complete **6 laps**.

**Sprint laps:** 1, 3, 5



The **3k knockout** Competition will be organized on a **1.5km /1km /0.5Km** courses, same shape (Closer to event, detailed Info will be added).

## 13. RULES

Please note that all the events in the World Cup will be conducted according to latest World Aquatics Competition Regulations, in force at the time event.

## 14. ACCREDITATIONS & EVENT INFORMATION DESK

### Accreditation:

The Organising Committee will provide all competitors and Team Staff with an official Accreditation. Only accredited people will be allowed to access certain venue areas. All accredited people are requested to always carry their Accreditation with them and to show them upon request.

Accreditations will be collected at the Information Desk in the official hotels upon arrival. Team Officials will be required to present photographic identification for all team members.

### Information Desk

The official hotels will have an Information Desk where all the information related to the competition will be provided.

## 15. POINT SYSTEM & PRIZE MONEY

## 16. MEDICAL

All Medical Support will be delivered by the local health authorities and in articulation with the World Aquatics Medical and Safety Officers, as well as World Aquatics Rules and Procedures.

## 17. VISA INFORMATION & TRANSPORTATION

All visitors to Setúbal, Portugal should have a valid visa for their entry and stay in the country.

The Portuguese Swimming Federation will facilitate an entry visa to Portugal to all participants and coordinate all the required procedures upon completion of registration in the World Aquatics GMS no later than **2 May 2026**.

Transportation schedules will be provided upon arrival and as part of the detailed Information Pack.

## 19. CANCELLATION POLICY

Any cancellation after the registration deadline of **2 MAY 2026** will be subject to pay full amount of the accommodation.

Any new bookings received after registration deadline of **2 MAY 2026** will be subject to availability and 20% extra charge.

Payment deadline: 18 MAY 2026 (after this date 20% extra charge)

## 20. ANTI-DOPING

Urine and blood samples will be collected during the competition for the purpose of doping controls. The doping controls will be done in accordance with the World Aquatics Doping Control Rules and the World Anti-Doping International Standards, which can be consulted [here](#). The operations will be supervised and coordinated by the International Testing Agency (ITA).

The list of prohibited substances can be consulted [here](#). For reminder, all athletes are strictly responsible for any prohibited substance found in their sample and it is particularly important for them to check any medication they take against the prohibited list. Additionally, all athlete support personnel are responsible to be knowledgeable about anti-doping regulations and procedures.

Mandatory Anti-Doping education course prior to participation:

### **Athlete**

As per the World Aquatics Doping Control Rules, any athlete participating in World Aquatics Events must, prior to participation, have successfully completed the eLearning Anti-Doping Education course "[International-Level Athletes Education Program](#)" or a course developed by their respective NADO and recognised by the AQIU (Aquatics Integrity Unit).\* Any athlete who has not met this requirement will not be eligible to compete and thus will not have their accreditation activated.

### **Team Official: Coach, Head Coach, Chef de Mission, Team Leader, or Support Staff**

As per the World Aquatics Doping Control Rules, anyone registered as a team official—including coach, head coach, chef de mission, team leader, support staff—for World Aquatics Events must, prior to participation, have successfully completed the eLearning Anti-Doping Education course "[Coaches of High Performance Education Program](#)" or a course developed by their respective NADO and recognised by the AQIU (Aquatics Integrity Unit).\* Anyone who has not met this requirement will not be eligible to participate and thus will not have their accreditation activated.

### **Team Official: Doctor, Medical Professional, Massage Therapist, or Physiotherapist**

As per the World Aquatics Doping Control Rules, anyone registered as a team official—including doctor, medical professional, massage therapist, physiotherapist—for World Aquatics Events must, prior to participation, have successfully completed the eLearning Anti-Doping Education course "[ADEL for Medical Professional's Education Program](#)" or a course developed by their respective NADO and recognised by the AQIU (Aquatics Integrity Unit).\* Anyone who has not met this requirement will not be eligible to participate and thus will not have their accreditation activated.

#### \* AQIU (Aquatics Integrity Unit) Recognised NADO Education Programs

Please refer to the list of anti-doping education programs from National Anti-Doping Organisations (NADOs) whose certifications are recognised by the AQIU [here](#). These certifications will be accepted as fulfilling the mandatory anti-doping education requirements for all World Aquatics competitions.

#### Steps to Complete the ADEL Certification

Please follow these instructions in order to complete the ADEL course:

##### Step 1:

Access the eLearning course webpage [here](#).

##### Step 2:

Click on "Register here" and follow the steps to register an account.

##### Step 3:

Sign in to the new account just created.

##### Step 4:

Based on the category, select the course "**International-Level Athletes Education Program**", "**Coaches of High-Performance Education Program**" or "**ADEL for Medical Professional's Education Program**" and complete the course to obtain at least 80% at the final exam at the end of the course. You can do the course again if you do not achieve 80% the first time. The athletes' course is available in twenty-three languages, the coaches' course in seventeen languages, and the medical professionals' course is offered in three languages. Each course takes up to 2-3 hours to complete. The courses can also be accessed through the "**ADEL by WADA**" mobile application.

##### Step 5:

Once the course has been successfully completed, download the certificate of completion, and send it to your World Aquatics Member. The ADEL guidelines to download the certificate can be found [here](#). **Step 6:**

The World Aquatics Member must upload the certificate of completion of each athlete on their respective GMS profile [here](#) (in the Sport tab).
